SEISMIC UPDATES in the 2019 CALIFORNIA BUILDING CODE and CGS NOTE 48

Seismic requirements in the 2019 California Building Code (CBC) are based on ASCE 7-16. Changes in seismic requirements in ASCE 7-16 are significant compared to the previous code version and these changes may significantly impact the scope and cost of geotechnical design in California. Architects, Engineers, Developers, and Owners need to be aware of the impacts the seismic changes in the building code will have on their projects. CGS has also updated their Note 48 which covers the geologic and seismic hazards for schools, hospitals, and community colleges. This presentation will provide the details of these changes in the seismic requirements and how they can impact geotechnical recommendations.

He has published and presented more than forty technical papers in international journals and conferences. He has also been an invited speaker at universities and professional engineering associations across the US.
